

TERMS, CONDITIONS AND PRIVACY POLICIES MEETSUPER.COM

These conditions of use of the **SUPER** website, regulate the terms and conditions of access and use thereof, which is owned by **SUPER** with address at Acuña de Figueroa 1781, Buenos Aires, Argentina.

SUPER is a company that provides advertising, marketing and media services. By using the website, the user will automatically accept, without limitation of any kind and without reservations, each and every one of the clauses of the Terms and Conditions. If you do not agree with the Terms and Conditions, you must refrain from using it.

The user must read them carefully before using the web. The entry and navigation through it has no cost, as well as the subscription to newsletters and / or communications that **SUPER** carries out or may carry out in the future.

Registration

Prohibited uses

The purpose of this website is to publish services.

SUPER will not be responsible for the inappropriate use of the website or contrary to these terms and / or laws of Argentina.

The user will not use the **SUPER** website to transmit, communicate or disseminate, in any way, opinions or illegal, defamatory, vulgar content or that in any other way may hurt the sensitivity of others or violate the values or dignity of the person . Any use of the website for illicit purposes or those that harm or prevent, may damage and / or overload, in any way, the use and normal operation of the website and that directly or indirectly threaten the same or against any third party is prohibited.

Modifications

SUPER ensures the proper use of the web users and their full satisfaction in relation to the contracted services.

This is why **SUPER** reserves the right to make changes and / or modifications and / or maintenance, without limitation, of the services.

SUPER shall modify these terms periodically, so in order to know the latest ones, the user must periodically access them.

Data Protection

SUPER assumes the responsibility of complying with current legislation on national and international data protection (General Data Protection Regulation -

RGPD Regulation-) and has the objective of treating your data in a lawful, loyal and transparent manner.

SUPER stores and processes personal data that have been provided by the user for the registration on the web and the contracting of services. The data will be processed by **SUPER** addressed at Acuña de Figueroa 1781, Buenos Aires, Argentina.

It is the user's responsibility to keep access to it secure. **SUPER** will not be responsible for the possible damages that the user may suffer from the use of the web.

SUPER complies with national and international regulations on data, providing security on them.
